Formats include: print, representational, audiovisual, electronic, digital (social media, accessible through internet, or software applications) that contain content that is sexually explicit. Please be aware that nudity in of itself is not sexually explicit unless the nudity is sexual in natural or portrayed in a lewd manner. Also, sexual orientation alone is not a reason to identify a material as sexually explicit.

\_\_\_\_\_ "Sexually explicit content" means (a) any description of or (b) any picture, photograph, drawing, motion picture film, digital image or similar visual representation depicting sexual bestiality, a lewd exhibition of nudity, as defined in this policy, sexual excitement, sexual conduct or sadomasochistic abuse, as defined in this policy, coprophilia, urophilia, or fetishism.

\_\_\_\_\_ Contains "Sadomasochistic abuse" meaning actual or explicitly simulated flagellation or torture by or upon a person who is nude or clad in undergarments, a mask or bizarre costume, or the condition of being fettered, bound or otherwise physically restrained on the part of one so clothed.
